PURPOSE AND EFFECT OF APPLICATION:

To reduce the minimum side yard setback required for an accessory building in the Residential Serviced - First (RS1) zone from 1.2 metres (3.94 feet) to 0.6 metres (1.97 feet) to accommodate the construction of a detached garage on the subject property.

TAKE NOTICE THAT an application under the above file number will be heard by the Committee of Adjustment on the **22nd of February** at 6:00 PM under the authority of Section 45 of the Planning Act.

FAILURE TO ATTEND HEARING – If you do not attend this public hearing, it may proceed in your absence and, except as otherwise provided in the Planning Act, you will not be entitled to any further notice in the proceeding. Statutory Powers Procedure Act, R.S.O. 1990, c.S.22, s 7.

NOTICE OF DECISION – A certified copy of the decision, together with a notice of the last day for appealing to the Local Planning Appeal Tribunal shall be sent, not later than 10 days from the making of the decision, to the applicant, and to each person who appeared in person or by counsel at the hearing and who filed with the secretary-treasurer a written request for notice of the decision.
