Areas of Nominations

A person may be nominated as a participant in a sport (athlete, coach, manager, organizer or any combination of these) or as a sports builder (developer or promoter). Basic Requirements

Nominees must meet at least one of the following requirements in order to be considered for the South Stormont Sports Hall of Fame:

1. They lived in South Stormont for 5 years 2. They participated in sports in South Stormont

#### **OUR HISTORY**

The South Stormont Sports Hall of Fame, while still in its infancy, has a long and interesting history of athletes to choose from. Prior to the creation of the the St. Lawrence Seaway, and their amalgamation, Cornwall Township and Osnabruck Township have had a long and proud sporting history. On July 1st, 1958 the villages of Mille Roches, Moulinette, Wales, Dickinson's Landing, Farran's Point and Aultsville and the hamlets of Woodlands, Santa Cruz, and Maple Grove became the villages of Long Sault and Ingleside in Cornwall Township and Osnabruck Township respectively. In 1998 Cornwall Township and Osnabruck Township were amalgamated into the Township of South Stormont.

With all these changes, one thing remained constant - the quality of the athletes. If you know of a noteworthy athlete whose sporting roots reach back to South Stormont (Cornwall Township or Osnabruck Township) why notnominate them as a South Stormont Sports Hall of Fame candidate.

#### SUBMISSIONS

Submissions should include the following items:

1. A history of the person's involvement including the years in which the person was involved, specific dates of achievements and levels of competitions such as local, district, provincial. Canadian and international 2. Supporting documentation such as newspaper clippings, pictures, awards received, championships, records set, ...

#### BUDGET

One of the most important tasks each year are the budgets which require good planning.

The Township passes a budget that consists of two parts: an operating budget, which includes all the expenditures required to deliver the day-to-day Township services and the expected revenue (i.e., user fees, permits, etc.), and a capital budget, which includes one-time expenditures for major projects or infrastructure whether new or existing (i.e., roads, trails, parks, etc.).

## **BUILDING DEPARTMENT**

#### WHEN ARE BUILDING PERMITS REQUIRED?

Building permits are required for, but not limited to; the construction or alteration of any structure over 10m<sup>2</sup> (107ft<sup>2</sup>) in area, a structure of any size containing plumbing, tents over 60m<sup>2</sup> (645ft<sup>2</sup>) and pools.

## HOW DO I APPLY FOR A BUILDING PERMIT?

You can apply online for a building permit with our online system, Cloudpermit.

The Cloudpermit building permit system allows you to apply for and to see the status of your application anywhere, at any time.

Alternatively, you can apply for a building permit in person at the Township Office

## WHY SHOULD I APPLY FOR A BUILDING PERMIT?

Building permits regulate construction so that health, safety, accessibility, and energy efficiency standards are met. Commencing construction without the issuance of a building permit is in contravention of the Building By-law and the Building Code Act of Ontario.

#### **DID YOU KNOW?**

Throughout the first 6 months of 2021, the Township of South Stormont Building Department issued 106 permits and carried out 784 inspections - facilitating over \$16 million in building activity (that's nearly double the \$8.7 million in building activity from January-June 2020!)

## WHEN SHOULD I APPLY FOR A BUILDING PERMIT?

It is recommended that you apply for building permits 6-8 weeks prior to the anticipated start date of your project. Although it may not take that long to process your application, it does allow time for unexpected delays due to the high volume of applications, missing information, conformance with zoning regulations, etc.

#### WHEN AND HOW DO I REQUEST BUILDING INSPECTIONS?

A list of required inspections is indicated on each building permit.

After each stage of construction is completed, building permit holders are required to notify the Township by emailing <u>building@southstormont.</u> <u>ca</u> or calling 613-534-8889 Ext. 233 at least 2 full business days in advance to request an inspection.

## WHAT ARE THE SETBACKS TO BUILD ON MY PROPERTY?

Property setbacks are available online in the Township's Zoning by-law; however, they are dependent on the zoning of your property. Please contact <u>kim@southstormont.ca</u> or <u>building@southstormont.ca</u> to confirm your property's zoning information.

#### WHAT IS A SEVERANCE?

A land severance is for the creation of a new lot, the enlargement of an existing lot, for easement purposes, to give access with a right-of-way or to correct property titles.

Although the United Counties of Stormont, Dundas and Glengarry are the approval authority for Consents/Severances, the Township of South Stormont will help you complete the application and get the process started.

#### WHAT IS A MINOR VARIANCE?

The Township's Comprehensive Zoning By-law provides a number of specific requirements and provisions for properties within South Stormont. In some instances, applicants can seek relief from some of these specific requirements through the process of a Minor Variance.

Once an application has been received, a Minor Variance is ruled on by the Committee of Adjustment. Prior to filling out an application, please consult with the Planning Department to determine the nature and extend of the Minor Variance required.



## Clearing The Way This Winter

The Township of South Stormont Public Works Department asks for you to remember that once cold temperatures return, snow clearing activities will commence and we need your help to ensure snow removal is completed effectively and safely.

Remaining safe is a joint responsibility. When you see a snowplow or salt truck on the road, please proceed with caution. Snowplows are built to remove large volumes of snow and ice and that means they're packing a lot of weight. Give time and space to the vehicles at work for you.



- Turn on your head and taillights during heavy snow or rain, even during the day.
- Watch for the flashing blue LED lights. It can be difficult to see snow removal equipment because of blowing snow.
- Give yourself extra time to get to your destination. To do the job right, snowplows and salt trucks must travel slower than regular traffic.
- Give snowplows plenty of space about 10 car lengths. Salt and winter abrasives, as well as rocks and other debris in the snow, can fly hitting nearby vehicles and decreasing visibility.
- Remember the road surface ahead of the plough hasn't been ploughed yet, therefore please slow down and be patient.
- Don't assume the snowplow operator can see you, especially if you're driving too close and visibility is poor due to blowing snow.
  Don't pass snowplows. It increases the risk of collision. When drivers attempt to pass a plow truck, they put themselves, their passengers, other motorists and the snowplough operator at risk.
  Don't Tailgate.
  Tailgating any vehicle puts you at risk of a collision; tailgating a snowplow in winter driving conditions increases the risk.

#### **DID YOU KNOW?**

- The Township provides winter maintenance for over 300km of roads and 15 km of sidewalks.
- Road salt works poorly when temperatures drop below -12C. That is why bare pavement can be difficult to restore in extremely low temperatures.
- The combination plow/salt unit completes the assigned route on an average of 6 hours.
- 1106 tonnes of stone dust/salt mix is applied annually.
- 381 tonnes of salt is applied annually.

Please Remember - Sidewalk snow clearing will also commence once the snow flies. Please ensure that vehicles, garbage and recycling bins are not obstructing the plow operator's ability to effectively clear the sidewalks.

#### Did you know that garbage collection is one of the most hazardous occupations in Canada?

The Township's Public Works employees are well trained and wear protective clothing, but sometimes injuries occur due to improper disposal of sharp items in curbside garbage. Broken glass is one major hazard that has caused injury to Township employees. Broken glass is NOT recyclable and should be disposed of properly to ensure it makes its way safely to the landfill.



#### Tips to safely dispose of BROKEN GLASS

- Wrap broken glass in several layers of old cloth.Use a hammer to gently break into smaller
- pieces.

• Place the wrapped glass in a box and seal with strong tape.

• Write **DANGER** – **BROKEN GLASS** in large letters on the box.

• Place at the roadside alongside your regular garbage.

Free Access Landfill Pass – Please contact Town Hall or visit our website to request your landfill pass for 2 free loads per year. Free Pass cannot be used to dispose of construction materials.

**Recycle Materials at Landfill Site** The Landfill Site is equipped to accept recyclables. If you miss your recycling collection or have a large amount to dispose of, simply bring it to our Landfill site **free of charge**. Containers have been set up to take cardboard and other recyclables at this location.

Please remember to keep cardboard to a maximum size of  $1m \times 1m \times 30cm$  and do not mix it with other recyclables.

#### **E-Waste at Landfill**

E-waste is accepted at our Landfill Site **free** of charge. Accepted materials include: computers, keyboards, monitors, and TVs (no wooden consoles).

**Did you know...** E-waste can be dropped off at the Habitat for Humanity ReStore Seaway Valley during normal business hours, 7 days a week, 1400 Vincent Massey Dr, Cornwall, 613-938-0413. #### **Tips for Setting Out Your Waste**

- Due to a number of factors, collection times may change. Please be on time and place ALL items at the curb by **7:00 a.m.** on your garbage and recycling day.
- During winter months, ensure that material is free of snow and ice and visible to the collection crew. Do not place materials on top of snowbanks.
- Do not dispose of syringes and needles in your garbage or recycling. It is illegal and dangerous. Please contact your pharmacy or place of purchase for proper disposal methods.

#### GARBAGE

• Residents may place a maximum limit of two (2) 82 litre garbage bags / containers per week for collection at the curb. Commercial businesses and registered farms are permitted up to a maximum of six (6) 82 litre garbage bags / containers per week.

- Only regular household garbage placed in garbage bags or bags within containers with handles, weighing less than 23 kg (50 lbs.), will be collected. Leaf and yard waste will not be accepted with regular garbage collection.
- Avoid accidents and injury. Remember people are handling your waste. Be mindful of the material you place out for collection as well as how it is set out. Wrap broken glass in cloth, break it into smaller pieces with a hammer and put it in a box clearly marked with contents before placing it out for collection.

#### RECYCLING

- Recyclable material is collected every second week on the same day as your garbage. Please refer to the map on the reverse to establish your recycling collection day.
- Bundle and tie all corrugated cardboard in bundles and place beside your Recycling Box.

 Save space and prevent litter; squeeze pop cans, large plastic bottles and beverage cartons. Remember to bundle and tie cardboard to save space in the truck and to prevent litter on the streets and roadways.

- Secure your recyclables.
  Stack your Recycling Boxes one on top of the other to prevent papers from blowing away.
- Empty and dried paint cans can be placed out for recycling.







The Township of South Stormont and the City of Cornwall have an agreement for **Township residents** to dispose of both hazardous waste and e-waste at the City of Cornwall depot at 2590 Cornwall Centre Road West.

#### Depot open from April to November:

• Two Saturdays per month - 7:30am-12 noon

Two Wednesdays per month
 - 7:30am-4:30 pm

(Please see the monthly calendar on reverse for exact dates)

#### Items accepted at the depot include: Paint: Latex and oil-based

**Corrosive:** Vehicle batteries, drain cleaner **Flammable:** Lighter fluid, turpentine, gasoline, used oil, diesel and furnace oil

**Toxic:** Poisons, bleach, medications, pesticides, cleaning fluids, antifreeze and full aerosol cans

**Propane tanks:** Both the regular BBQ tanks and the smaller camping type cylinders **E-Waste:** As described previously

Additionally, the Trillium Road Landfill Site is open every Friday and Saturday from 8:00 am to 4:00 pm to accept leaf and yard waste **at no charge.**



## **MUNICIPAL LAW ENFORCEMENT**

#### WINTER PARKING

By-law 2015-021 regulates parking on highways and private property within the Township of South Stormont. A copy of the By-law is available on our website.

Please park your vehicle in your driveway, well off the road, until street and sidewalk clearing operations are completed. This allows our crews to do their job and make the streets and sidewalks safe for everyone. Vehicles interfering with snow removal or blocking sidewalks may receive a parking ticket.





#### **RESPONSIBLE PET OWNERSHIP**

The Township of South Stormont's animal services are regulated under the Responsible Pet Ownership By-law.

The Township's Responsible Pet Ownership By-law limits the number of cats to three (3) per dwelling unit in urban settlement areas. Cat owners are not required to license their cat(s) but must comply with the regulations of the By-law.

Anyone operating a dog kennel facility within the Township must apply annually for a kennel licence.

In addition to your pet's official licence, DocuPet also provides:

- A quick and easy online solution for purchasing and renewing your pet's licence

The Responsible Pet Ownership By-law requires every owner to register their dog(s) with the Township and purchase a tag. Registering your dog(s) not only shows responsible pet ownership but also helps with identification and safe return of your pet if they are found running at large.

## **HOME SAFE HOME PROGRAM**

Residents may have their home inspected by the Fire Prevention Officer free of charge. This will help homeowners identify and correct any hazards and ensure all smoke and carbon monoxide alarms are working properly. If you are interested in booking an appointment for your home to be inspected, please call the Township office at 613-534-8889 ext. 251.

#### SMOKE AND CARBON MONOXIDE ALARMS

#### Do you have working Smoke and Carbon Monoxide Alarms in your home? - It's the Law!

Homeowners and landlords are responsible for ensuring their properties have working smoke and carbon monoxide alarms. This includes:

#### Testing:

• It is recommended that smoke and carbon monoxide alarms be tested monthly or in accordance with the manufacturer's instructions.

#### **Batteries:**

• Replace batteries in smoke and carbon monoxide alarms once a year or whenever the low-battery warning sounds.

• Know the difference between a low-battery warning and an emergency alarm - consult the manufacturer's instructions.

#### **Replace alarms:**

 In accordance with the manufacturer's. instructions

• Know what the "end-of-life" warning sounds like consult the manufacturer's instructions.



#### Landlords:

• Landlords are responsible to ensure working smoke and carbon monoxide alarms are installed and maintained in their rental properties.

• The law requires landlords to test smoke and carbon monoxide alarms in rental units annually and when the battery is replaced, changes are made to the electric circuit or a change in tenancy occurs. Test your alarm by using the test button.

• The law requires landlords to provide the manufacturer's maintenance instructions to tenants.

#### Tenants:

• The law requires tenants to notify the landlord if the smoke and carbon monoxide alarms are inoperable. • It is against the law for tenants to remove the batteries or tamper with the alarm in any way.





#### DAY 1 Water fresh trees daily

It's time to trim that Christmas tree, and if you're using a real tree, buy a fresh tree and keep the base of the trunk in water at all times. Keep your tree away from any ignition source such as the fireplace, heaters or candles.



#### DAY 4 Make sure you have working carbon

Carbon monoxide is an invisible, odourless gas that can quickly kill you. Replace any carbon monoxide alarms over seven years old. Installing carbon monoxide alarms in your home will alert you to the presence of this deadly gas.



Before you put those lights on the tree or around the front window check the cords closely. Discard any sets that are frayed or damaged.



#### DAY 5 Make sure everyone knows how to get out safely if a fire occurs

Develop and practise a home fire escape plan with all members of the household and make sure someone helps young children, older adults or anyone else that may need assistance to evacuate. Once outside, stay outside and call 911 from a cell phone or neighbours house.



DAY 7 **Give space** heaters space

If you are using space heaters to help take the chill off. remember to keep them at least one metre (3 feet) away from anything that can burn such as curtains, upholstery, or holiday decorations.



#### **DAY 10** Watch what you heat!

The holiday season is one of the busiest times of the year, which means it's easy to get distracted from what we are doing. Cooking fires most commonly occur when cooking is left unattended. Always stay in the kitchen when cooking; especially if using oil or high temperatures. If a pot catches fire, carefully slide a tight-fitting lid over the pot to smother the flames and then turn off the heat.



#### DAY 8 When you go out, blow out!

Candles can set the perfect mood for a holiday celebration, but remember to always blow out candles before leaving the room or going to bed. Keep lit candles safely away from children and pets and anything that can burn, such as curtains, upholstery, or holiday decorations. Be candle safe!



Careless smoking is the leading cause of fatal fires. If you do allow smoking indoors use large, deep ashtrays that can't be knocked over and make sure cigarette butts are properly extinguished.



#### DAY 3 Make sure you have working smoke alarms

With family and friends spending extra time at your home over the holidays, it's a great time to check your smoke alarms. Replace smoke alarms if they are over 10 years old. Remember that you need working smoke alarms on every storey of your home and outside all sleeping areas. Test your alarms to make sure they will alert you and your family if a fire occurs, giving you the precious seconds you need to safely escape.



#### DAY 6 Use extension cords wiselv

People often use extension cords for that extra set of lights or the dancing Santa in the corner. Extension cords should be used only as a temporary connection. Make sure cords never go under rugs as this can cause damage to the cord and cause a fire.



#### DAY 9 **Keep matches and** lighters out of the sight and reach of children

People often keep matches and lighters handy to light holiday candles. But matches and lighters can be deadly in the hands of children. If you smoke, have only one lighter or book of matches and keep them with you at all times.



#### There's more to responsible drinking than taking a cab home

With all the festive cheer this time of year, keep a close eve on anyone attempting to cook or smoke while under the influence of alcohol. Alcohol is all too often a common factor in many fatal fires.




