



**PUBLIC MEETING  
ZONING BY-LAW AMENDMENT  
APPLICATION Z-2025-08  
TOWNSHIP OF SOUTH STORMONT**

**TAKE NOTICE** that the Council of the Corporation of the Township of South Stormont will hold a public meeting on **October 22nd, 2025** at **5:00PM** at the Town Hall, 2 Mille Roches Road, Long Sault, to consider a proposed Zoning By-law amendment under Section 34 of the Planning Act.

**THE PURPOSE** of this Zoning Amendment is to rezone the lands described as Par West Half Lot 10 Concession 5 Geographic Township of Cornwall, Part of Part 6 on Plan 52R-2792; Township of South Stormont (17463 Headline Road):

From: “Residential Single-Service - First (RSS1) Zone” and “Residential Single-Service - First – Holding (RSS1-h) Zone”

To: “Residential Single-Service - First – Special Exception 20 (RSS1-20) Zone”

**THE EFFECT** of the proposed rezoning to RSS1-20 would allow for an “agricultural use, small” and a riding arena for a limited number of horses on the lands, in accordance with the Rural (RU) zone requirements for such uses.



If a person or public body would otherwise have an ability to appeal the decision of the Township of South Stormont to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of South Stormont before the by-law is passed, the person or public body is not entitled to appeal the decision.

Only individuals, corporations and public bodies may appeal a By-law to the Ontario Land Tribunal. A Notice of Appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

If a person or public body does not make oral submissions at the Public Meeting or make written submissions to the Township of South Stormont before the By-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the Tribunal’s opinion, there are reasonable grounds to do so.
